The Washington State Motor Vehicle "Lemon Law" is designed to help new vehicle owners who have substantial continuing problems with warranty repairs. The law allows the owner to request an arbitration hearing through the Attorney General's Office. There will be no charge for the arbitration process. At the hearing, the arbitrator will decide whether a consumer's claim meets the requirements under the law.

When the "lemon" is used as a trade-in on another vehicle without going through the "Lemon Law" process, the "lemon" value may be deducted from the price of the new vehicle and retail sales tax is due on the balance, if there is any.

The Lemon Law in the state of Washington covers "new" or "used" vehicles that were originally purchased or leased within the state and that were intended for use on public roads, including motorcycles. However, the vehicle must weigh less than 19,000 pounds and must have been covered by the vehicle manufacturer's warranty when sold.

What is the Lemon Law in Washington? The WA lemon law protects new vehicle owners from serious defects covered under the manufacturer's warranty. Drivers must submit a request for an arbitration hearing within 30 months of buying the vehicle to qualify. If your claim is accepted, the lemon law buyback policy states that manufacturers must replace the vehicle or repurchase it from you.

First, the Washington Lemon Law protects consumers who buy or lease motor vehicles, including demonstration vehicles, certain motorcycles, and motor homes. The Washington Lemon Law also covers some used motor vehicles bought with less than 24,000 miles and within 2 years from the original sale or lease date. The Washington Lemon Law applies to 2 kinds of defects: (1) serious safety defects (life threatening vehicle problems) and (2) defects that substantially impair a car or truck's use ...

A state's lemon laws, therefore, are designed to hold manufacturers and dealers accountable for lemons, requiring replacement or a full refund within a specified amount of time. Washington's lemon laws allow customers to receive a refund or replacement within two years or 24,000 miles after delivery.

This law gives owners of "lemons" the remedy of a new vehicle or a refund of the vehicle purchase price, less a reasonable allowance for the use of the vehicle. According to Washington Lemon Law, there are four requirements that must be met for a car to be a lemon:

Washington Lemon law RCW 19.118.900. Effective dates-1987 c 344, Section 9 of this act is necessary for the immediate preservation of the public peace, health, and safety, the support of the state government and its existing public institutions, and shall take effect June 1, 1987.
